The General Academic Regulations which are in [Section IV](#) (General Academic Regulations) of the University Calendar apply to and regulate the programmes listed above.

On occasion, programmes can be exempted from one or more of the clauses in the General Academic Regulations, or one or more of the clauses can be varied.

- *Exemptions are characterised by the omission of the relevant clause.*
- *Variations are characterised by the replacement of the clause with alternative wording.*

The programmes listed have approval from the Academic Quality and Standards Committee for the exemptions and/or variations to the regulations noted below.

Additional requirements are also listed.

These regulations apply to pre-sessional students enrolled from 1 June 2018.

Exemptions

The following programmes are exempt from Clause 3.2 of the [Progression, Determination and Classification of Results: Pre-sessional Programmes](#):

- All Undergraduate programmes, except English or English combined.

- Postgraduate Taught programmes in English, History, MMus (Musicology and Composition Pathway) and Philosophy.
